GRENDAIN STATISTICAL
REPORT OF INDICATORS,
1 JANUARY TO 30 SEPTEMBER 2009



The Grenada Drug Information Network (GRENDAIN), IS THE National Observatory on Drugs in Grenada. It is the system through which Grenada coordinates the collection and dissemination of information from all institutions involved in the area of drug control.

It is also a mechanism to inform policy makers and the general public about statistical data on drug-related matters.

The network is made up of all institutions which collect drug-related statistics

GRENDAIN has significantly improved Grenada's ability to participate in local, regional and international drug control projects.

GRENDAIN was established by Cabinet in December 2002.

Number Of Persons Arrested And Charged For Drug-Related Offences

- Five hundred and nineteen (519) persons were arrested and charged for drug-related offences. (Males: 487; Females: 32)
- Seventy (70) persons twenty years and under were arrested and charged. (Males: 67; Females: 3)

Number Of Persons Arrested And Charged For Possession Of Drugs Within One Hundred Yards Of Schools

- Two (2) persons were arrested and charged for possession of drugs within a radius of 100 yards of a school.

Type And Quantity Of Drugs Seized By Law Enforcement Officers

- Cannabis plants: 11,472 units
- Marijuana Cigarettes: 1,770 units
- Marijuana: 467.12 kg
- Cocaine: 86.95 kg
- Crack: 740 g

Number Of Criminal Deportees To Grenada

- Thirty-two (32) persons were deported to Grenada for criminal offences. (Males: 29; Females: 3)

Number Of Persons Arrested And Charged For Money Laundering

- Two (2) persons arrested and charged for money laundering offences.

Number Of Persons Sentenced to Prisons For Drug-Related Offences

- Sixty-three (63) persons were imprisoned for drug-related offences. (Males: 61; Females: 2)
- Ninety-seven (97) percent of persons convicted to prisons for drug-related imprisonment were males and three (3) percent were females.

Age Range & Percentage Of Persons Imprisoned For Drug-Related Offences

- 15-19 years: 1 persons (2 %)
- 20-24 years: 8 persons (13 %)
- 25-29 years: 9 persons (14 %)
- 30-34 years: 9 persons (14%)
- 35-39 years: 7 persons (11 %)
- 40 years and over: 29 persons (46%)

Number Of Patients Admitted To Rathdune Psychiatric Unit For Drug Abuse-Related Problems

- One hundred and eighty-two (182) persons were admitted to Rathdune Psychiatric Unit for drug abuse. (Males: 177; Females: 5)

Number Of Patients Admitted To General Hospital For Drug Abuse-Related Problems

- One hundred and twelve (112) persons were admitted to the General Hospital. (Males: 95; Females: 17)

Number Of Patients Admitted To Carlton House Treatment Centre For Drug Abuse

- Sixteen (16) persons were admitted to Carlton House Treatment Centre. (Males: 16; Females: 0)
