



GRENDAIN STATISTICAL REPORT OF INDICATORS (SUMMARY):



1 JANUARY 1988 TO 31 DECEMBER 2009

The Grenada Drug Information Network (GRENDAIN) is the mechanism through which Grenada coordinates the collection and dissemination of drug-related statistical information.

GRENDAIN is comprised of all institutions involved in the implementation of the national drug control program. It was established in 2002. The Drug Control Secretariat, which is the National Observatory on Drugs in Grenada, performs the administrative functions of GRENDAIN.

Number Of Persons Arrested And Charged For Drug-Related Offences: 1988 - 2009

- Eight thousand, and three (8, 003) persons were arrested and charged for drug-related offences. (Males: 7,429; Females: 574)
- One thousand, one hundred and eighty-seven (1,187) persons twenty years and under were arrested and charged. (Males: 1, 053; Females: 134)

Number Of Persons Arrested And Charged For Possession Of Drugs Within One Hundred Yards Of Schools: 1998 – 2009

- Eighteen (18) persons were arrested and charged for possession of drugs within 100 yards of school.

Type And Quantity Of Drugs Seized By The Royal Grenada Police Force: 1988 - 2009

- Cannabis Trees: 314,212 units
- Marijuana Cigarettes: 32,077 units
- Marijuana: 10,167.63 kg
- Cocaine: 1, 109.72 kg
- Crack: 15.185 kg
- Ecstasy: 3, 338 units
- Methamphetamines: 89 units

Number Of Criminal Deportees: 2004 – 2009

- Three hundred and eighty-three (383) persons were deported to Grenada for criminal offences. (Males: 361; Females: 22)

Number Of Persons Arrested And Charged For Money Laundering: 2004 – 2009

- Seventeen (17) persons were arrested and charged for offences related to money laundering.

Number Of Persons Imprisoned For Drug-Related Offences: 1988 - 2009

- One thousand, six hundred and sixty-seven (1,667) persons were imprisoned for drug-related offences. (Males: 1,590; Females: 77)
- Ninety-five (95) percent of persons convicted to prisons for drug-related imprisonment were males and five (5) percent were females.

Age Range Of Persons Imprisoned For Drug-Related Offences: 1988 - 2009

- 15-19 years: 60 inmates (4 %)
- 20-24 years: 243 inmates (14 %)
- 25-29 years: 313 inmates (19 %)
- 30-34 years: 363 inmates (22%)
- 35-39 years: 345 inmates (21 %)
- 40 years and over: 343 (20 %)

Number Of Patients Admitted To Rathdune Psychiatric Unit For Drug Abuse: 2003 – 2009

- Two thousand, one hundred and thirty-four (2,134) persons were admitted to Rathdune Psychiatric Unit for drug abuse. (Males: 2,029; Females: 105)

Number Of Patients Admitted To General Hospital For Drug Abuse: 2003 – 2009

- Eight hundred and thirteen (813) persons were admitted to the General Hospital. (Males 693; Females: 120)

Number Of Patients Admitted To Carlton House Treatment Centre For Drug Abuse: 1988 - 2009

- One thousand and thirty-six (1,036) persons were admitted to Carlton House Treatment Centre. (Males: 963; Females: 73).
