



# FISCAL SUMMARY

## May 2018

1. A primary surplus of \$16.3m was realized for the month of May 2018.
2. Current Revenue for the month was \$61.1m, which was \$0.4m more than the collections for May 2017.
3. Grants received amounted to \$4.1m, \$0.3m below the amount received in May 2017.
4. Total expenditure for the month was \$63.7m of which current expenditure was \$60.3 million and capital expenditure was \$3.4m. The total expenditure for May 2018 was \$4.7m below the amount spent in May 2017.
