

FISCAL SUMMARY September 2017

- 1. Current Revenue for September 2017 was \$51.1m, \$1.1m below the target for the month of September and \$0.5m above the 2016 September collections.
- 2. Grants received in September 2017 amounted to \$6.6m.
- 3. Total expenditure for the month of September was \$53.0m, \$6.3m under the targeted \$59.3m.
- 4. A primary surplus of \$9 m was realized for the month of September 2017, which was above the projected surplus of \$8.5m.
