

FISCAL SUMMARY November 2017

- 1. Current Revenue for November 2017 was \$60.1m, 1.2 m above the target for the month of November and \$5.4m above the 2016 November collections.
- 2. Grants received in November 2017 amounted to \$11.5m.
- 3. Total expenditure for the month of November was \$79.6m, \$2.4m under the targeted \$82.0m.
- 4. A primary surplus of \$13.3m was realized for the month of November 2017.
