



FISCAL SUMMARY

December 2016

1. Current Revenues for the month of December were \$58.9m, which was \$6.7m above the target; and \$0.3m less than the collections for December 2015.
2. Grants for December 2016 amounted to \$8.6m; which was \$0.7m below the projections of \$9.3m.
3. Total expenditure for the month of December was \$56.4m. This is an increase of \$2.8m when compared to the \$53.6m , which was projected.
4. A primary surplus of \$15.8m was realised for the month of December 2016.

5. Total revenues and grants were \$61.5 million above the target for the year 2016; and \$101.9m higher when compared to the year 2015.
6. There was a shortfall in grant spending by \$16.9m. However, total grants for 2016 increased by \$21.7m relative to 2015.
7. Total expenditure amounted to \$685.6m, which was in line with what was anticipated. Of that amount, \$565.5m was for recurrent expenditure and \$120.1m for capital expenditure.
8. A primary surplus of \$148.3m was realised in 2016 compared to \$109.1m, which was targeted.
