The Government of **Saint Vincent and the Grenadines** has received financing from the World Bank toward the cost of the **Saint Vincent and the Grenadines' Solar PV Demonstration and Scale-up project**, and intends to apply part of the proceeds toward payments under the contract for **the supply and installation of a solar photovoltaic (PV) array for the Saint Vincent and the Grenadines' Community College, Division of Vocational and Technical Education.**
